On the back of this page, please find a form which owners of broodmares participating in the Pennsylvania Breeding Fund program and are intending to foal in 2010, **must** file with PHBA. The information submitted on the form will provide PHBA with a basis from which to identify and confirm the presence of mares in the state, as defined below in the eligibility criteria for PA-Bred registration.

Please fill out this form completely, and return it to PHBA no later than **October 15, 2009**. The form may be copied for additional broodmare reporting. If you are boarding mares for clients new to the program, please direct them to PHBA's website, **www.pabred.com**, where a copy of this letter and form can be downloaded from the home page link ****NEW** 2010 Broodmare Domicile Report FORM** for their convenience and compliance.

ELIGIBILITY CRITERIA FOR PA-BRED REGISTRATION

A Thoroughbred foal born in the state of Pennsylvania and registered as such with The Jockey Club is eligible for Pennsylvania-Bred registration with the Pennsylvania Horse Breeders Association if one of the following conditions is met:

- For foals of 2007, the dam of the foal resided continuously in Pennsylvania since November 1, 2006, through foaling.
- For foals of 2008 and thereafter, the dam of the foal resided continuously in Pennsylvania since October 1 of the year of conception through foaling.
- The dam of the foal was purchased at a public sale after October 1 of the year of conception and brought into Pennsylvania within 14 days of the date of purchase and remained continuously through foaling. During the year of foaling, the foal or its dam spent at least ninety (90) days in the state.
- The dam of the foal was bred to a stallion standing in Pennsylvania which was registered with the Pennsylvania Horse Breeders Association as a Pennsylvania stallion during the breeding season of the year of foaling, and said dam of the foal remained in the state for at least the next ninety (90) days after foaling.

PA BROODMARE DOMICILE REPORT – FOR MARES FOALING IN 2010

Report to be Signed by Broodmare Owner

MANDATORY - MUST File by October 15, 2009, or within 15 days thereafter of PA Arrival

FOAL REGISTRATION CRITERIA - A Thoroughbred foal born in the state of Pennsylvania in 2010 and registered as such with The Jockey Club is eligible for Pennsylvania-Bred registration with the Pennsylvania Horse Breeders Association if one of the following conditions is met:

- (1) The dam of the foal resided continuously in Pennsylvania on or before October 1, 2009, through foaling; or
- (2) The dam of the foal was purchased at a **public** sale after October 1, 2009, then brought into Pennsylvania within 14 days of the date of purchase, and remained in Pennsylvania through foaling. During the year of foaling (2010), the foal or its dam must spend at least 90 days in the state; or
- (3) The dam of a foal will be bred in 2010 to a stallion standing in Pennsylvania which is registered with the Pennsylvania Horse Breeders Association as a Pennsylvania stallion, and said dam of the foal will remain in Pennsylvania for at least the next 90 days after foaling.

AFFIDAVIT OF DOMICILE BY BROODMARE OWNER

I assume full responsibility for all information regarding this broodmare, and agree that if the broodmare is determined to be ineligible based upon inaccurate, false, or fraudulent information: (1) the foal may be ineligible for registration as a Pennsylvania-Bred; (2) I may be forever denied the privilege of registering PA-Breds; (3) I may be forever denied the benefit of any and all breeder awards; and (4) any awards paid based upon the performance of an ineligible foal shall be returned in full by the recipient to the Pennsylvania Breeding Fund. Furthermore, I agree to promptly provide any additional information requested by the official registrar, PA Horse Breeders Association, to confirm information submitted with this broodmare domicile form. I understand that the statements herein are made subject to the penalties of 18 PA C. S. 4904 (relating to unsworn falsification to authorities).
